## **Role Description**

The Regional Col Cadets is the principal ACF and CCF(Army) post in each RPOC. They are senior by appointment to all ACF Commandants, even though they are of the same rank. The Regional Colonel will normally exercise a wide range of authority across both the ACF and CCF(Army) on behalf of their RPOC Commander. They will have excellent people management skills, good administrative abilities and a keen desire to be deeply involved in the higher management of the Army Cadets Forces, both within their RPOC, and by working with the Colonel Cadets Council at national level.
